SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

General Advice

Immediate and specialised first aid and medical treatment is required. Speed is of the essence. Flush with plenty of water immediately. Continue flushing during transport to hospital or medical center.

Eye Contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. In the case of contact with eyes, rinse immediately with plenty of water and seek medical advice.

Skin Contact

Wash off immediately with plenty of water for at least 15 minutes. Immediate medical attention is required. Dermal burns may be treated with calcium gluconate gel or slurry in water or glycerine. This compound binds the active fluorides in an insoluble form and limits burn extension and pain. Soaking or immersion with iced 0.13% Benzalkonium chloride solution may be used for skin burns and should be continued until the pain is relieved. Do not use in eyes.

Ingestion

Do NOT induce vomiting. Call a physician or poison control center immediately.

Inhalation

If not breathing, give artificial respiration. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Remove to fresh air. Immediate medical attention is required. A nebulized solution of 2.5% Calcium gluconate may be administered with Oxygen by inhalation.

4.2. Most important symptoms and effects, both acute and delayed

Causes burns by all exposure routes. Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated: Ingestion causes severe swelling, severe damage to the delicate tissue and danger of perforation

4.3. Indication of any immediate medical attention and special treatment needed

This product contains hydrogen fluoride. Generous application of calcium gluconate gel to the affected skin may be indicated. For dermal exposure, the use of 2.5-33% calcium

gluconate or carbonate gel or slurry has been recommended. The gel is either placed into a surgical glove into which the affected extremity is then placed or applied directly on the burn.
